Dear Chief,

On April 10th, 2018 a Special Grand Jury [Petition](#) with [57 exhibits](#) was filed with (then) U.S. Attorney Geoffrey Berman, now Audrey Strauss in the Southern District of New York, and the United States Department of Justice regarding the destruction of the three World Trade Center skyscrapers. The petition was submitted by the Lawyers' Committee for 9/11 Inquiry, **demanding** that the U.S. Attorney present evidence of unprosecuted Federal crimes at the World Trade Center on September 11th, 2001. On November 7th, 2018 the U.S. Attorney's office [agreed in writing](#) that they would comply with the provisions under 18 USC § 3332. The letter was signed by Mr. Michael Ferrara and Mr. Ilan Graff, Chiefs of Terrorism and International Narcotics Unit.

On July 24th, 2019 the Franklin Square and Munson Fire Department unanimously passed a [Resolution](#) in support of this Grand Jury Petition. Accordingly, we respectfully request your assistance in contacting U.S. Attorney Audrey Strauss to express either your support for the petition, or request the status of the Petition, or both.

You are acting on behalf of a **Mutual Aid Request** for assistance and information from a brother volunteer Fire Department in New York that sustained losses at the World Trade Center on 9/11/01. You have every right to make such an inquiry, especially about a Federal Grand Jury investigation.

I'm sure you want justice to prevail here. That's what it's all about Chief; justice and doing the right thing. My friends, and the other people who were murdered and died horrible deaths that day, deserve that much, as they paid for it with their lives. Justice for the victims, including my friends, FDNY Firefighters Bobby Evans, Mike Kiefer and FDNY Thomas Hetzel, who was also a volunteer firefighter with the Franklin Square and Munson Fire Department, requires nothing less and the soul of our nation commands it. The worthiest memorial we can provide for those who were murdered on 9/11 and for those who have died as a result of the events of 9/11, including many First Responders is discovery and public disclosure of the full truth.
